The Board of County Commissioners to Conduct A Public Hearing for the Purpose of Receiving Public Comment on Three Capital Projects

October 10, 2023 - The Board of County Commissioners (BOCC) will be holding a public hearing on Monday, October 16th, 2023 at 6:00 PM, to discuss three capital projects: The Justice Center Expansion, Jail Pod Completion, and Sheriff's Office Expansion to Hayden. The hearing will provide an opportunity for citizens to learn more about the proposed project cost, where the money will come from, ask questions, and provide feedback. The hearing is open to the public. All interested parties are encouraged to attend.

The short notice of this public hearing is in an effort to avoid costs from delaying the Justice Center Project. However, the BOCC felt it was prudent to seek public feedback before proceeding with phase 2 of the Justice Center expansion as costs continue to rise. The BOCC appreciates the Public's consideration to this urgent matter.
